

# A Promising Tomorrow for South Carolina Schools

### **Giving Chester County New Hope**

In 2014, the South Carolina Supreme Court ruled that educational equity must be ensured for school districts that are located in challenging economic areas in the state of South Carolina.

Since that ruling, Learning.com has partnered with the South Carolina Education Oversight Committee and Department of Education to provide districts with poverty indices of 80% or greater free access to digital literacy curriculum. There are currently 46 districts in the state that are eligible to participate, serving more than 150,000 K-8 students at 323 schools.

Chester County School District in Chester, SC was among the first of the eligible districts to participate. The K-12 district's territory is spread over a large geographical area, but enrollment is on the smaller side at 5,300 students, a high percentage of which qualify for free and reduced lunches.

#### **Less Is More**

When Sharon Yarbrough took on her position as the Instructional Technology Coordinator at Chester, one of her first responsibilities included overseeing the implementation and use of technology in the schools. One discovery she made, when initially assessing the district's technology resources, was that they had many resources that essentially did the same thing.

"We needed to evaluate how to best utilize the funding we were receiving, and although we had many resources, we wanted to make sure that our students were accessing these programs and growing academically," said Yarbrough. "Another conclusion we reached was that even though many resources were available, students were not gaining the 21st century digital skills needed to be successful."



From there, the district needed to determine which software programs they wanted to continue with, and then examine which ones they needed to eliminate, to save on unnecessary spending.

During the decision-making process, what rose to the surface was the district's need to incorporate digital literacy and the need for resources to help.

We needed to evaluate how to best utilize the funding we were receiving, and although we had many resources, we wanted to make sure that our students were accessing these programs and growing academically."
